# THE PAW HOUSE, LLC - AGREEMENT, RELEASE AND MEDICAL POWER OF ATTORNEY

**Terms.** The Paw House, LLC is hereinafter referred to as “Bones & Bacon Doggy Daycare”. Dogs may only be dropped off or picked up during Bones & Bacon’s Doggy Daycare posted normal business hours. Bones & Bacon Doggy Daycare will use its best efforts to maintain its facilities in a safe and sanitary manner. By signing this agreement, I represent that I am the legal owner/guardian of my dog, and that my dog has current inoculations including but not limited to inoculations against distemper/parvo, bordetella, and rabies. I understand and acknowledge that my dog will be kept in the company of other dogs during its stay here at Bones & Bacon Doggy Daycare. I am willingly and knowingly inserting my dog into this environment where accidents may occur. I understand that my dog must have a suitable collar or harness and proper identification tags. I give Bones & Bacon Doggy Daycare permission to take pictures of my dog for use in its advertising and promotional materials, and any pictures so taken become the property of Bones & Bacon Doggy Daycare. I understand that Bones & Bacon Doggy Daycare may terminate my dog’s stay at any time in its sole and absolute discretion, and that if my dog’s stay is terminated I will promptly pick up my dog, or send an authorized party to do so. I understand that daycare, boarding, and grooming products/services are nonrefundable.

**Additional Services.** I understand that if I do not provide sufficient food for my dog that Bones & Bacon Doggy Daycare will provide its own food for a fee. I understand that the following services are available upon request and for additional charges: bathing and nail clipping.

**Charges.** I understand that I am responsible for all fees and charges that my dog incurs during its stay at Bones & Bacon Doggy Daycare. I understand that if I am late picking up my dog I may be charged for all additional time that my dog spends at Bones & Bacon Doggy Daycare. I agree that if I pay by check and my check is not honored when presented for payment that Bones & Bacon Doggy Daycare may charge the full amount due plus a returned check fee of \$25.

**Assumption of Risk.** I hereby give Bones & Bacon Doggy Daycare permission to care for my dog and to do any and all things required in the ordinary and normal course of providing such care. Bones & Bacon Doggy Daycare may use leashes, collars, and other appropriate means of maintaining control over my dog. I understand that Bones & Bacon Doggy Daycare is not responsible or liable for any of the following: injuries (or death) to my dog caused by other dogs (including being bitten); diseases or ailments which my dog may contract from other dogs including infections and viruses; falls; theft; collisions with vehicles; running away; natural disasters; fire; the unavailability of emergency medical care or any items necessary for the care of my dog due to circumstances beyond the control of Bones & Bacon Doggy Daycare (including food, water, medicine, and electricity); the negligence or deliberate acts of third parties; or injuries or death to my dog caused by themselves including but not limited to hanging themselves, ingesting foreign objects, chewing themselves, chewing foreign objects, or running away. I understand that Bones & Bacon Doggy Daycare is not responsible for any personal property left with Bones & Bacon Doggy Daycare, including but not limited to beds, blankets, clothing, bowls, food, collars, leashes, or toys.

**Veterinary Care.** If, in my absence, my dog should be injured, appears sick, or otherwise requires immediate veterinary attention as determined by Bones & Bacon Doggy Daycare in its sole and absolute discretion, I hereby authorize Bones & Bacon to consult with any veterinarian for treatment or guidance. I authorize Bones & Bacon Doggy Daycare to utilize the services of any veterinarian selected by Bones & Bacon Doggy Daycare. I understand that I am responsible for any charges, including transportation costs, incurred with respect to any such veterinary services. I name Bones & Bacon Doggy Daycare as my attorney-in-fact in my name to accomplish the foregoing.

**Release of Liability and Indemnification.** I hereby release Bones & Bacon Doggy Daycare, its owners, employees, contractors, or any other persons or entities involved with the services provided by Bones & Bacon Doggy Daycare from all actions, suits, or claims for injury, loss or damage regardless of the cause (with the sole indiscretion of intentional wrongdoing of Bones & Bacon Doggy Daycare). I also release the owner of the facility (“Owner”) which Bones & Bacon Doggy Daycare occupies from all actions, suits or claims for injury, loss or damage regardless of the cause (with the sole indiscretion of intentional wrongdoing of the Owner). I understand and acknowledge that dogs can be extremely unpredictable and may cause damage to themselves, other dogs, persons or property for which Bones & Bacon Doggy Daycare could be liable. I agree to indemnify and hold harmless Bones & Bacon Doggy Daycare and Owner for any and all losses, liabilities, demands, expenses, claims and suits, including any legal, veterinary or other fees Bones & Bacon Doggy Daycare or Owner may incur as a result of any damage caused by my dog, and I agree to defend Bones & Bacon Doggy Daycare and Owner against such. I further understand that if my dog causes injury to another dog / person that I am responsible for all corresponding veterinary / medical care expenses. It is the intention of the parties that the foregoing releases shall be effective as a bar to all actions, claims, losses, liabilities, damages, or costs, of any kind or nature, known or unknown, foreseeable or unforeseeable, arising out of the performances of Bones & Bacon’s Doggy Daycare’s services. The parties expressly agree that this release of liability and indemnification shall be given full force and effect in accordance with each and all of its terms and provisions.

I understand that this Agreement is a contract between Bones & Bacon Doggy Daycare and myself, and that it contains a power of attorney, release of liability and indemnity. If any portion of this Agreement is deemed unenforceable, all other portions shall be given full effect to the extent possible. In the event of a dispute between the parties, the prevailing party shall be entitled to recover all costs and expenses incurred therein, including attorney’s fees. This Agreement contains the complete understanding of the parties with respect to the subject matter herein and supersedes all prior representations and understandings, whether oral or written. This Agreement may be modified only by a writing signed by both parties.
